## Bylaw 96-02 A BYLAW TO AUTHORIZE ENTERING INTO AN AGREEMENT WITH THE MOOSEJAW - THUNDER CREEK DISTRICT HEALTH BOARD

WHEREAS the Rural Municipality of Craik No. 222 is a Municipality as defined in section 2 of the Hospital Revenue Act and is permitted by section 17 of the said Act to enter into an agreement with a hospital/district health board for the purpose of making a grant to that hospital/district health board;

NOW THEREFORE, the Council of the Rural Municipality of Craik No. 222 in the Province of Saskatchewan, in a open meeting assembled enacts as follows:

- 1. The schedule attached hereto and marked schedule "A" shall take effect in all respects as schedule "A" to Bylaw No. 96-02.
- 2. The Reeve and the Administrator are hereby authorized, empowered and directed, to execute the agreement incorporated herewith as Schedule "A" to this bylaw and forming part thereof, and to affix the corporate seal of the Rural Municipality of Craik No. 222 and to do and to cause to be done all acts, matters and things which may be necessary for the due performance and fulfillment of the said agreement.
- 3. This bylaw shall come into force and take effect from and after the day of final passing thereof.

## AGREEMENT SCHEDULE "A" TO BYLAW 96-02

THIS AGREEMENT made in quadruplicate this 6th, day of August, 1996

BETWEEN:

THE RURAL MUNICIPALITY OF CRAIK NO. 222 a body corporate under the laws of the province of Saskatchewan, hereinafter called "Municipality"

OF THE FIRST PART,

and

THE MOOSE JAW-THUNDER CREEK HEALTH BOARD, in the City of Jaw, in the Province of Saskatchewan represented by its board, hereinafter called the "Board" OF THE SECOND PART,

WHEREAS section of 4 of the Hospital Revenue Act exempts the "Municipality" from liability of payments of the said act upon entry by it into an agreement the Minister of Finance with a "Board" whereby the Municipality is obligated to make a grant the "Board" in lieu of said

NOW THEREFORE, this agreement witnesses as

- The "Municipality" agrees to pay to the "Board" a grant equivalent to two mills of taxation in the R.M. of Craik Mo.222 less the applicable early discount, before December 31st, 1996; 1.}
- The service provided by the "Board" will be available to all residents of the "Kunicipality"; 2.)
- The "board" agrees to use the grants paid by the "Kunicipality", pursuant to clause (1) for capital expenditures or for such other purposes as the "Board" 3.1 shall direct;
- This agreement shall not be valid unless the bylaw authorizing the "municipality" to enter into this agreement is approved by the Minister of Health and the Local Government Countitee of the Saskatchewan Municipal 4.) Board as provided under section 17 of the Mospital Revenue Act.
