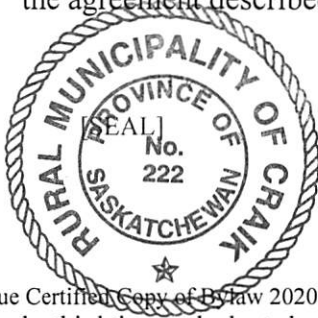
## RURAL MUNICIPALITY OF CRAIK NO. 222

### BYLAW NO 2020-03

#### A BYLAW TO PROVIDE FOR THE MUNICIPALITY TO ENTER INTO AN AGREEMENT WITH THE CRAIK AND DISTRICT REGIONAL PARK.

The Council of the Rural Municipality of Craik No. 222 in the Province of Saskatchewan enacts as follows:

1. In this bylaw:
  - a. "Administrator" shall mean the administrator of the municipality;
  - b. "Council" shall mean the council of the municipality;
  - c. "Head of council" shall mean the reeve of the municipality, as the case may be;
  - d. "Municipality" shall mean the Rural Municipality of Craik No. 222;
2. The Rural Municipality of Craik no. 222 is hereby authorized to enter into an agreement with the Craik and District Regional Park for the purpose stated within the agreement.
3. The agreement is attached hereto and forms a part of this bylaw, and is identified as "Exhibit A".
4. The head of council and the administrator are hereby authorized to sign and execute the agreement described as Exhibit A.

**REGIONAL

AGREEMENT**

**CRAIK AND DISTRICT REGIONAL PARK**

WHEREAS the parties named above desire to continue to associate with each other for the purpose of further developing and maintaining the Regional Park known as **THE CRAIK AND DISTRICT REGIONAL PARK** established under The Regional Parks Act, 1979 and the parties wish to make financial contributions in the amounts stated in this agreement for a further three-year period.

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of these presents and the covenants, promises, and agreements hereinafter contained, the parties jointly and severally agree as follows:

1. TO CONTINUE to associate and work together and appoint representatives to THE CRAIK AND DISTRICT REGIONAL PARK AUTHORITY to further develop, operate and maintain THE CRAIK AND DISTRICT REGIONAL PARK. The municipalities shall appoint the following number of representatives to the Regional Parks Authority:

Town of Craik - a maximum of three representatives

R.M. of Craik -- a maximum of three representatives

R.M. of Arm River - a maximum of two representatives

R.M. of Sarnia - a maximum of two representatives

R.M. of Huron - a maximum of two representatives

The parties may contact the Board for assistance in finding representatives to sit on the board.


2. TO CONTINUE to develop, operate and maintain that area of land now designated as the **CRAIK AND DISTRICT REGIONAL PARK** and more particularly described as follows:

All that portion of the North West Quarter of Section Twenty-four (24) in Township Twenty-four (24) in Range Twenty-eight (28) West of the Second Meridian, in the Province of Saskatchewan, in the Dominion of Canada as Parcel "A" Plan No. 72MJ14586.


All that portion of the North West Quarter of Section Twenty-four (24) in Township Twenty-four (24) in Range Twenty-eight (28) West of the Second Meridian, Saskatchewan described as follows: Commencing at the South West

5. THIS AGREEMENT shall be renewable at the end of three years should the municipalities participating under this agreement so desire.


